SUPPORT+FEED IS DEDICATED TO CREATING AN EQUITABLE, PLANT-BASED FOOD SYSTEM THAT NOURISHES PEOPLE AND PROTECTS THE PLANET. FOUNDED IN 2020, OUR PURPOSE IS PRIMARILY TO PROVIDE PLANT-BASED MEALS PREPARED BY LOCAL VEGAN RESTAURANTS TO PEOPLE EXPERIENCING FOOD INSECURITY AND TO EDUCATE THE PUBLIC ABOUT THE BENEFITS OF PLANT-BASED EATING. IN 2024 WE HELPED PROVIDE 800,000 MEALS AND PANTRY ITEMS ACROSS 11 US & INTERNATIONAL CITIES, REACHED NEARLY 4 MILLION PEOPLE THROUGH DIGITAL ENGAGEMENT, AND HELD 122 ONSITE CLASSES AND EVENTS. BOARD MEMBERS AND 250 VOLUNTEERS CONTRIBUTED 6,152 HOURS IN 2024, VALUED AT \$252,053.
